**CONTEST VOTING PERIOD:** The Contest starts on February 15, 2021 at 12:00 PM Central Time and ends on March 18, 2021 at 11:59 AM Central Time (the “**Contest Voting Period**”).

## **I. RULES FOR PARTICIPATING**

**ELIGIBILITY:** The potential participants in the Contest are determined by Administrator, in conjunction with Sponsor, and must be current high school students in good standing who are on track to graduate at the end of the 2020-2021 academic school year or otherwise have completed their high school basketball career or exhausted their eligibility, sixteen (16) years of age or older (with parent or legal guardian consents where necessary), and legal residents of the forty-eight (48) contiguous United States and the District of Columbia. Employees of Sponsor, Administrator, CBS, Inc. (“**CBS**”), and their respective parents, subsidiaries, affiliates, promotion and advertising agencies, members of their immediate family (spouses, parents, children, and siblings and their respective spouses, regardless of where they reside), and persons living in the same household, of such employees (whether or not related), are NOT eligible to participate. Void where prohibited by law. The Contest is subject to all applicable federal, state, and local laws.

### **OPTIONAL COMMERCIAL COMMUNICATIONS AND DATA CAPTURE:**

**For Entrants:** Entrants have the option as part of the entry process to receive follow up communications which may include commercial communications from Sponsor, however, choosing to receive such communications is not necessary to enter or win the Contest. If, at any

time, an entrant no longer wishes to receive promotional emails from Sponsor, that entrant may click on the Unsubscribe link included in the email. Additional information and Sponsor's privacy policy is posted at <https://www.amfam.com/privacy-security>.

**For Voters:** People seeking to vote in the Contest will be required to register with the Contest's website, which will collect voter data (including name, address, phone, country of residence, and email address as well other consumer information) to be shared with Sponsor for follow up communications from Sponsor which may include commercial communications. Voters have the option as part of the registration process to receive commercial communications from Sponsor, however, choosing to receive such communications is not necessary to register to vote the Contest. If, at any time, a voter no longer wishes to receive communications from Sponsor, that voter may click on the Unsubscribe link included in the email. **COMPLETING ENTRY:** To complete the entry procedure as a participant in the Contest, potential participants must complete the following by February 1, 2021:

1. Return a properly signed copy (by parent or legal guardian where necessary) of these Official Rules to Administrator;
2. Post a video of participant's basketball highlights from the applicable category (slam dunk, boys' three-point, or girls' three-point) on Youtube which complies with the entry terms below and provide Administrator with a link via email to the posted highlight video;
3. Provide Administrator with a written answer to the question, "What is your basketball dream?";
4. Complete the participant Release and Waiver as well as other documentation provided by Administrator; and
5. Provide Administrator with a headshot that is cleared for use in the online competition.

**BINDING AGREEMENT:** In order to enter the Contest as a participant, you must agree to these Official Rules (these "**Official Rules**"). These Official Rules consist of: (i) the terms and conditions outlined herein; (ii) an entry form; and (iii) a parental consent form (collectively, "**Contest Materials**"). If you are a minor, you must obtain the prior permission of your parent and/or legal guardian, who must also agree to these Official Rules on his/her and your behalf before you can enter the Contest. Because these Official Rules form a legally binding agreement with respect to the Contest, please read them carefully. If you do not agree to these Official Rules, you are not eligible to participate in the Contest or to win any of the prizes. You agree that registration for the Contest and/or a submission of an entry in the Contest constitutes your agreement to these Official Rules.

**REQUIREMENTS OF ENTRY VIDEOS:** Entry videos may not contain, as determined by Administrator, in its sole discretion, any content that:

- defames, misrepresents or contains disparaging remarks about other people or companies;
- contains trademarks, logos, or trade dress (such as distinctive packaging, uniforms or building exteriors/interiors) owned by others, without permission; contains any personal identification, such as license plate numbers, personal names, e-mail addresses or street addresses;

- contains copyrighted materials owned by others (including commercial music, photographs, proprietary game footage, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media), without permission;
- contains materials embodying the names, likenesses, voices, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead, without permission;
- contains look-alikes of celebrities or other public or private figures, living or dead;
- communicates messages or images inconsistent with the positive images and/or good will to which we wish to associate;
- promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promotes any activities that may appear unsafe or dangerous; promotes any particular political agenda or message;
- is obscene or offensive; endorses any form of hate or hate group; or
- violates any law.

Entry videos must not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity. If the entry video contains any material(s) or element(s) that are not owned by the participant, and/or which are subject to the rights of third parties, the participant is responsible for obtaining, prior to submission of the entry video, any and all releases and consents necessary to permit the use and exhibition of the entry video by Sponsor and/or Administrator in the manner set forth in these Official Rules, including, without limitation, name and likeness permissions from any person who appears in or is identifiable in the entry video, necessary music licenses, etc. Administrator reserves the right to request proof of these permissions in a form acceptable to Administrator from any participant at any time. By submitting an entry video, participant warrants and represents that he/she and any persons appearing or who are identifiable in the entry video consent to the submission and use of the entry video in the Contest and to its use as otherwise set forth herein.

By submitting an entry video, participant acknowledges and agrees that Sponsor and Administrator shall have the right to edit or alter the entry video in any manner that Administrator deems necessary in its sole discretion, including, without limitation, replacing or editing out commercial music, adding content or text regarding the official Contest information and directions for the Contest Voting Period and/or adding any other elements.

By submitting an Entry video, participant hereby grants permission for the entry video to be posted on [www.amfam.com/fanvote](http://www.amfam.com/fanvote) and/or other websites. Participant agrees that Released Parties (as defined below) are not responsible for any unauthorized use of the entry video by third parties. All entries will become the property of Administrator and Sponsor and will not be returned to participants.

Proof of submitting an entry online or via a device is not considered proof of delivery or receipt by Administrator or Sponsor.

Only participants selected by Administrator/Sponsor as detailed below are eligible to participate in the Contest.

**SELECTION OF PLAYERS:** Prior to the Contest Voting Period, based on their judging criteria, in their sole discretion, a committee of independent judges compiled by Sponsor and Administrator

will determine sixteen (16) finalists from all possible participants in each of three (3) categories. The committee shall select finalists based equally upon their demonstrated skillset and statistics throughout their high school career, character, and leadership qualities. Administrator will screen each potential Player (as defined below) for eligibility prior to the Contest Voting Period. Sixteen (16) finalists deemed eligible by Administrator shall be selected to participate in the slam dunk bracket of the Contest (the “**Dunkers**”), sixteen (16) finalists deemed eligible by Administrator shall be selected to participate in the girls’ three-point bracket of the Contest (the “**Girls Shooters**”), and sixteen (16) finalists deemed eligible by Administrator shall be selected to participate in the boys’ three-point bracket of the Contest (the “**Boys Shooters**,” and collectively with the Dunkers and the Girls Shooters, the “**Players**”). During the Contest Voting Period, the Players will be voted on by the public at [www.amfam.com/fanvote](http://www.amfam.com/fanvote) (the “**Website**”) in three (3) bracket-style competitions featuring a profile and highlight reel for each Player.

**CONTEST PROCESS:** During the Contest Voting Period, Players will be voted on by the public on the Website in three (3) bracket-style competitions – one (1) for the Dunkers, one (1) for the Girls Shooters, and one (1) for the Boys Shooters – featuring a profile and highlight reel for each Player. All profiles and highlight reels are property of Sponsor and will not be returned. Voters (as defined below) can vote up to once per device per calendar day for each head-to-head bracket match-up via the Website. The one (1) Player with the highest number of valid votes in each head-to-head bracket match-up will advance to the next round of the Contest, as further detailed below. The one (1) Player from each of the three (3) brackets receiving the highest number of valid votes in the final head-to-head bracket match-up will be deemed a “Grand Prize Winner” (for a total of three (3) total Grand Prize Winners for the Contest) and will receive an invitation to receive a roster spot at the applicable portion of the 2021 American Family Insurance High School Slam Dunk & 3-Point Championships currently scheduled to take place on March 30, 2021, in the Indianapolis, IN area (the “**Event**”), subject to verification of eligibility by Administrator and other Event requirements. The Administrator may be forced to modify the Event due to Force Majeure or other factors outside of the control of the Administrator. Administrator reserves the right to choose fewer than three (3) Grand Prize Winners or choose alternative Grand Prize Winners if, in its sole discretion, Administrator determines that there are voting irregularities or other unsportsmanlike conduct on the part of Players or Voters, or if COVID-19 or other condition(s) affect a Player’s ability to participate in the Event. Grand Prize awards are subject to Grand Prize Winners’ acceptance of the invitation, verification of eligibility, completion of necessary releases and related forms **and their ability to provide proof of a negative COVID-19 test acceptable to Administrator prior to travel**, for acceptance of the Grand Prize, and compliance with these Official Rules.

**SPIRIT OF THE CONTEST:** The spirit of the Contest is fair competition and good sportsmanship. Sponsor and Administrator expect Voters, Players, and their supporters to act accordingly. Sponsor and Administrator require that entrants/Players participate in the Contest and win it the “right way” through fair-play and creating up voting support in their schools and communities in ways that do not violate the terms or spirit of these Official rules. Using or encouraging unsportsmanlike means to get votes including, but not limited to, the following actions are prohibited, and if verified by Administrator, may be ground for disqualification from the Contest:

- payment for votes through online or other vote generating services;

- offer of giveaways or any other incentives for votes, or encouraging or knowingly allowing others to provide incentives for votes – which may include, but is not limited to, rewarding voters with merchandise, event tickets, services, autographs, or social, media likes, follows or similar;
- use of scripts, macros, bots, or any automated system to vote or with the intent to impair the integrity of the voting process during any Voting Period;
- using or encouraging the use of any process with the intent to impair the integrity of the voting process;
- disparaging or harassing conduct related to Players or Voters (either in-person or via digital or social media); and
- any other fraudulent, inappropriate, or unsportsmanlike conduct as determined in Administrator’s sole and absolute discretion.

Votes generated by any means that subvert these Official Rules or the spirit of the Contest may be declared void in the sole and absolute discretion of Administrator. Players/entrants deemed to have violated the spirit of the Contest, as determined in Administrator’s sole and absolute discretion, may be disqualified. Decisions by Administrator are final and binding on all matters relating to the Contest. By agreeing to participate in the Contest and Contest Voting Period, each Player and Voter agrees to abide by Administrator’s decisions and waives any and all claims (brought directly or on their behalf) arising out of Administrator’s decisions related to the Contest.

By participating in the Contest, each Player agrees and acknowledges that substantial swings in voting may occur during the Contest Voting Period without participants having violated these Official Rules.

By participating in the Contest, each Player further agrees that in the event Administrator, Sponsor, or CBS requests that such Player remove any publicity or other materials relating to the Player’s participation in the Contest or the Event, if applicable, from digital or social media or otherwise broadcast to the public, such Player will promptly comply with such requests.

**WINNER NOTIFICATION:** Each potential Grand Prize Winner will be notified by telephone, via social media, or by email. Grand Prize Winners (or the parent or legal guardian of a Grand Prize Winner if such winner is under the age of majority in his or her state of residence), will be required to execute and return, an Affidavit of Eligibility, a Liability and Publicity Release (except where prohibited by law), an Assignment of Rights, or a single document that includes these elements, and any other documents required by Administrator within two (2) business days of the date appearing on prize notification. Each potential Grand Prize Winner must also agree to follow all standard rules and regulations relating to their participation in the Event or they may be removed from the Event and no additional or alternative compensation or prizing will be provided. Return of prize notification as undeliverable, failure to sign and return requested documentation within the specified time period, the inability of Administrator to contact a potential Grand Prize Winner within a reasonable time period, or noncompliance with these Official Rules by any potential Grand Prize Winner will result in disqualification and, at Administrator’s sole and absolute discretion, the opportunity to be a potential Grand Prize Winner may be awarded to a runner-up Player.

**GRAND PRIZES (3):** A two (2) day/one (1) night trip to the Indianapolis area in connection with the Event where the winning Dunker, Girls Shooter, and Boys Shooter will have the opportunity

to participate in the applicable portion of the Event. Details of the Grand Prize Winners' participation in the Event will be determined in the sole discretion of Sponsor, the Event's coaching and training staff and Administrator.

Each Grand Prize Winner's prize will include roundtrip, coach class air transportation from a major U.S. gateway airport in the forty-eight (48) contiguous United States or the District of Columbia nearest the Grand Prize Winner's residence to the Indianapolis, IN area, or ground transportation,, one (1) night of standard hotel accommodations (one room, single occupancy, and all room taxes), and necessary ground transportation in the Indianapolis, IN area for participation in the Event and related official Event activities, official Event gear and merchandise, organized Event participant meals, and participation in the production around the Event. Ground transportation to and from Grand Prize Winner's home airport is not included. If a Grand Prize Winner resides within approximately a three hundred (300) mile radius of Indianapolis, IN, ground transportation will be provided in lieu of air transportation and no compensation, cash value or substitution will be provided with respect to any of these prize elements. The approximate retail value ("ARV") of each Grand Prize Winner's prize is One Thousand US Dollars (\$1,000) or less depending on transportation costs.

The total estimated value of all prizes which may be awarded in the Contest is Three Thousand US Dollars (\$3,000). Actual value of the prizes may vary based on Grand Prize Winner's residence, points of departure, and fares at time of travel. Any difference between stated value and actual value will not be awarded. The trips must be taken on dates specified by Administrator. Each Grand Prize Winner must have completed all required paperwork, including an Affidavit of Eligibility, a Liability and Publicity Release (except where prohibited by law), an Assignment of Rights, a participant release including COVID-19 release terms, or a single document that includes these elements, and any additional documents any additional documents as required, agree to participate in the Event, and each Grand Prize Winner must agree to participate in any media or recordings related to the Contest and the Event. Failure to comply with the foregoing may result in forfeiture of the prizes, in which case Sponsor and Administrator will have no further obligation to such Grand Prize Winner and may award the prize to an alternative winner. Sponsor and Administrator reserve the right to change the dates of any phase of the Contest or the Event in their discretion. Travel must be booked through Administrator's agent on a carrier of Administrator's choice.

All federal, state, and local taxes and all other costs associated with prize acceptance and use not specified herein as being provided, including transportation to and from the home airports, hotel incidentals, additional unspecified transportation, meals (aside from official participant meals), souvenirs, gratuities, and luggage fees are the sole responsibility of the Grand Prize Winner. An IRS Form 1099 may be issued in the name of each Grand Prize Winner for the actual value of the prize received. In the event a Grand Prize Winner engages in behavior that (as determined by Sponsor and Administrator in their sole discretion) is inappropriate, threatening, illegal, or that is intended to annoy, abuse, threaten, or harass any other person or which violates the terms or the spirit of these Official Rules, Sponsor and Administrator reserve the right to immediately terminate the use of the Grand Prize by that person, in whole or in part, and send the affected Grand Prize Winner home with no further compensation. Neither Sponsor nor Administrator shall be responsible for damages, losses, or injury resulting from acceptance or use of the Grand Prize elements. The Grand Prizes are awarded "as is" with no warranty or guarantee, either express or implied, by the Released Parties (defined below). Grand Prize Winners may not substitute, assign,

or transfer their prize or redeem any prize element for cash, but Sponsor and Administrator reserve the right, at their sole discretion, to substitute the prize (or any portion thereof) with one of comparable or greater value. All prize details are at Sponsor's and Administrator's sole and absolute discretion.

If a Grand Prize Winner is not available or eligible to travel on the dates specified, Sponsor and Administrator may, in their sole discretion, terminate the Grand Prize of such Grand Prize Winner, and an alternate Grand Prize Winner may be selected from the remaining eligible Players in Administrator's and Sponsor's sole discretion.

Travel restrictions, conditions, and limitations may apply. Travel arrangements are subject to availability and must be roundtrip. Sponsor and Administrator shall not be responsible for any cancellations, delays, diversions, substitutions, or any act or omissions whatsoever by the air carriers, hotels, other transportation companies, or any other persons providing any of these services and accommodations necessitated by same. Sponsor and Administrator shall not be liable for any loss or damage to any Grand Prize Winner's baggage. All travel dates are subject to change in the Sponsor's and the Administrator's discretion. If for any reason the Event is delayed, cancelled, or postponed, Sponsor and Administrator reserve the right, but are not obligated, to cancel or modify the Contest in their sole and absolute discretion and may award a substitute prize of equal or greater value, which may include, but is not limited to, a cash prize equivalent to the ARV of the trip portion of the Grand Prize as set forth in these Official Rules.

Each Grand Prize Winner is solely responsible for obtaining any and all necessary travel documents (including, but not limited to, valid photo identification, credit card, etc.) **as well a negative COVID-19 test result acceptable to Administrator** before departure. Sponsor and Administrator will not be responsible for any failure by a Grand Prize Winner to attend the events described herein due to flight or travel mishaps or delays or other reasons including, but not limited to testing positive for Covid-19 prior to traveling to the Event – in which case Administrator may select a replacement Grand Prize Winner. The Event dates and times are determined in the sole discretion of those entities responsible as hosts of the Event, as applicable, and may be subject to change. Sponsor and Administrator will not be responsible for Acts of God, acts of terrorism, civil disturbances, work stoppage, epidemic/pandemic, or any other natural disaster outside their control that may cause the cancellation or rescheduling of the Event.

**Should a Grand Prize Winner test positive for COVID-19 on-site, it is agreed that they will be transported home via ground in a private vehicle arranged by Administrator.**

**GENERAL CONDITIONS:** By participating in the Contest, each Player (and parent or legal guardian for any minor Players) agrees: (a) to abide by the terms and spirit of these Official Rules and the decisions of Sponsor, Administrator, and any judges of the Contest, which shall be final and binding in all respects relating to the Contest/Event and, if applicable, use of a Grand Prize; (b) to release, discharge and hold harmless Facebook, YouTube, Twitter, Instagram, Hudl, Sponsor, Administrator, CBS, other sponsors of the Event, the venue of the Event, and third parties responsible for execution of the Contest/Event, and their respective parents, affiliates, contractors, subsidiaries, and advertising and promotion agencies, and the respective officers, directors, shareholders, employees, agents, and representatives of the foregoing (collectively, the "**Released Parties**") from any and all injuries, liability, losses and damages of any kind to persons, including

death, or property resulting, in whole or in part, directly or indirectly, from participation in the Contest/Event or any Contest or Event related activity or the acceptance, possession, use, or misuse of any awarded prize including any travel or any activity related thereto **including, but not limited to any claims related to COVID-19**; and (c) to the grant of rights to Licensees (as defined and detailed below).

By participating in the Contest, each Player acknowledges that if they are chosen to participate in the Event, that the Event may include physical activities including, but not limited to, the following: running, passing, dribbling, shooting, jumping, body contact, and other basketball activities (the “**Activities**”). Each Player must warrant that they are physically fit and, if determined as a Grand Prize Winner, fully able to participate in the Activities and the Event and have not been advised to avoid the Activities by a medical practitioner **and will present proof of a negative COVID-19 test acceptable to Administrator prior to travel related to the Event**. Furthermore, each Player must have health, accident, and liability insurance to cover any bodily injury or property damage which they may suffer while participating in the Event and the Activities (if determined as a Grand Prize Winner). If a Grand Prize Winner does not have insurance as described above, he or she agrees to bear the costs of any injury or damage to themselves and in no event will Released Parties be liable for such costs.

By participating in the Contest, each Player (and parent or legal guardian for any minor Players) irrevocably grants to Administrator, Sponsor, CBS, their production and media partners related to the Contest and the Event, and their respective affiliates, agents, owners, officers, employees, vendors, sponsors, parent companies, their licensees, designees, successors, assigns and all other persons or entities acting in any capacity on their behalf (collectively, “**Licensees**”) all necessary rights to include Player’s name, voice, picture, portrait, likeness, and all statements and/or performances they may give and any footage taken at the Event, and make audio and video recordings of the Player, photograph the Player, and record the Player’s voice, conversation, and any performance he or she gives (including any musical compositions) and agrees that Licensees shall be exclusive owners of the results and proceeds of such taping, photography, and recording (collectively “**Content**”) with all rights including, but not limited to the right of publicity, throughout the world via all media (now known or subsequently developed) in perpetuity for all purposes including programming, advertising, publicity, and promotional purposes without compensation (unless prohibited by law) or additional consents from the Player (or anyone claiming through Player) or any third party and without prior notice, approval, or inspection. For the avoidance of doubt, each Player (and parent or legal guardian for any minor Players) further agrees that Licensees have an unlimited right to use Content in perpetuity in association with media related to the Contest and the Event or the Licensees and related promotions, to copyright, to use and to license others to use, in any manner, all or any portion thereof or of a reproduction thereof without payment or any additional compensation to any Player (or anyone claiming through the Player) or any third party or parties. Each Player (and parent or legal guardian for any minor Players) expressly waives any and all moral rights in connection with Content. By participating, each Player also agrees not to release any publicity or other materials on their own or through someone else regarding their participation in the Contest without the prior consent of Administrator, which may be withheld in the sole discretion of Administrator.

No payments or compensations are, or will be, due to the Players arising out of the grants of rights set forth herein and/or their participation. Nothing herein will constitute any obligation on the part of the Licensees to use any of the above rights. For any Player who is a minor at the time of

participation in the Contest or the Event, grants of rights or other legal obligations set forth herein shall be deemed to be undertaken by the applicable Player's parent or legal guardian with authority to legally bind such Player. No guild, union or performing rights terms shall govern uses of the Content or other rights granted hereunder.

**MISCELLANEOUS:** Released Parties are not responsible for lost, late, incomplete, damaged, inaccurate, stolen, delayed, misdirected, undelivered, or garbled profile, highlight reel or other Player materials (“**Materials**”) or communications received prior to pre-determining the eligible Players, nor for lost, interrupted or unavailable network, server, internet service provider, Website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing, or otherwise relating to or in connection with the Contest, including, without limitation, errors or difficulties which may occur in connection with the administration of the Contest, the tabulation of votes, the announcement of the prizes, the incorrect uploading of the video or in any Materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by Website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest. Released Parties are not responsible for injury or damage to any person's computer related to or resulting from participating and voting in the Contest or downloading materials from or use of the Website. Persons who tamper with or abuse any aspect of the Contest or the Website, who act in an unsportsmanlike or disruptive manner, or who are in violation of these Official Rules, as solely determined by Administrator, will be disqualified and all associated Players will be disqualified and/or votes will be void.
